Job Summary: The successful candidate will be a California-licensed, board-certified Pediatrician who has experience working with children of all ages and various medical conditions. Our clinic is a Rural Health Clinic (RHC). As such, we need a flexible, knowledgeable, and compassionate physician to provide for the care and well-being of children in our community.
